Verification of a Quorum - Secretary Steve Schwartz stated:

"The Bylaws of the Association require at least one hundred (100) voting members to establish a quorum. That number may be arrived at through proxy or absentee ballot, as long as at least twenty-five (25) voting members are physically present."

The tally at the close of balloting shows 1893 members voting either on line, by phone or write in ballot with 70 voting members physically present, thereby establishing a quorum.

- Vote on two Bylaw changes regarding staggering Director terms and irregular vacancies.
- Educate property owners on the general operations of the association and the rights and responsibilities of owners, the association, and the Board of Directors under Colorado law, and;
- Vote to allow any surplus funds remaining at the end of the fiscal year will be credited to the following year's budget.

The study was performed by an outside agency with suggested monies needed for the Reserve Fund which sets aside funds for repair and replacement of equipment and facilities. GM Roth reminded all Owners present that the Reserve Study is available on the plpoa.com website.

A summary of the plan's contents was covered. Highlighted that this Strategic Plan was the FIRST ever developed in the history of the PLPOA. Election Results – Steve Schwartz, Secretary

Board of Directors: (1822 total voters this ballot; vote for 2); Total weighted votes cast of ballot: 2071.22 (11.6% of 17866 total weighted possible votes)
Candice Kelly and Alynette Farley are new members to the Board of Directors receiving votes of 806.52 and 796.18 respectively. Sasha King received 468.52 votes.

Proposed Bylaw Amendment to Article V Section3 – "Terms of Office" (1873 total voters this ballot; vote for 1); Total weighted votes cast of ballot 1203.66 (13.5% of 8933 total weighted possible votes). Passed with 1129.24 Approve and 74.42 Disapprove.

Proposed Bylaw Amendment to Article V, Section8b - "Vacancies" (1867 total votes this ballot; vote for 1); Total weighted votes cast on ballot: 1196.68 (13.4% of 8933 total weighted possible votes). Passed with 1047.92 Approve and 148.76 Disapprove.

Acknowledgement of Election - President Bruce Jones Jr.

Owner Comments:

Rich Beaudry – Vista; expressed thoughts concerning Resolution 2018-05 regarding owner comments at Board Meetings. Later he stated his appreciation to legal counsel about notification/clarification on CCIOA budget vote in relation to owners

Chalyn Fitzgerald – Lakewood Village; concerned with water conservation, bear activity due to trash out, and assessment dues/fines implementation. At end of meeting she suggested Archuleta County Sheriff be invited to speak at annual meeting.

Gary Hardin – Pagosa in the Pines; enforcement of community rules with renters, 2nd homeowners not taking pride in their properties

Julie Cummings – Pagosa in the Pines; new owner with concerns of neighbors not caring for homes/property

Peter Beaudry – Vista; suggests PLPOA Board of Directors consider additional fees/permits STR's (short term rental) for property within the association ON TOP of Archuleta County fees/regulations

Paul Baird – Twincreek Village; agrees with previous owner comments regarding STR's Joyce Beaudry – Vista; as previous property manager her experience was that long term rentals presented similar concerns as STR's and that LTR

need to be regulated as a business too.

Gary Devloo – Pagosa in the Pines; questioned the Boards decision not to pursue acquiring the golf course. GM Roth responded that a NDA was in place.

Elaine Lundergan – Lake Forest Estates; concerned with safety of kids she has observed that do NOT wear life preservers while on SUP's. DPE Mgr Lynch responded lakes are patrolled and that lifejackets must be "onboard" for ages 12 and under.
